PLEASE READ ALL OF THE FOLLOWING.

THE FOLLOWING POLICIES CONCERN YOUR PRIVACY WHEN YOU ACCESS OR OTHERWISE USE THIS WEBSITE AND ITS SERVICES.

The website Portloads.com (otherwise referred to as "Portloads") is owned and operated by Portloads Inc, respectively (collectively "Portloads.com", "we", "us", "our", "site", "website", "company"). Your privacy is important to Portloads.com, and this Privacy Policy explains the data collection and privacy practices for users of the Site ("Privacy Policy"). This Privacy Policy does not pertain to information collected on any other site owned by Portloads.com, its subsidiaries or other businesses.

By visiting and using Portloads.com, you agree to abide by the terms and conditions of this Privacy Policy, and you consent to the collection, use and disclosure of your personal information by Portloads in accordance with the terms and conditions of this Privacy Policy. By visiting, using and/or registering with the Site, the individual person taking such action (i) agrees with, and agrees to comply with, this Privacy Policy and any updates, revisions or modifications to it and (ii) represents and warrants that he or she has the legal right to do so.

Portloads reserves the right to change, modify, add and/or remove provisions of this Privacy Policy. Any changes to this Privacy Policy will be posted here on this page, and we encourage you to check back from time to time to ensure continuing familiarity with the most current version of our Privacy Policy. At the bottom of this page, we will indicate the "Effective Date" of the most recent version of the Privacy Policy. This will allow you to determine whether the Privacy Policy has been revised since your previous visit to the Site.

I. What Information We Collect.

- a. **Non-Personally Identifiable Information.** When you enter Portloads.com, information is gathered from your Internet browser. This information may include your IP address and log files (which allows us to determine the identity of your Internet Service Provider), your operating system and the type of browser software that you are using to access this Site. All information obtained from your browser is anonymous, and no personal information is ever transmitted to us in this manner. Company may also automatically collect and record information about your visit (through the use of cookies, web beacons and otherwise) as part of its analysis of the use of the Site and its performance. A "cookie" is a small text file that a website can place on your computer's hard drive in order, for example, to retain your preferences and/or registration information for your next visit to that Website. The cookie transmits this information back to that website's operator. You can choose not to receive a cookie file by enabling your web browser to refuse cookies or prompt you before accepting a cookie. Note that refusing to accept cookies may impact the performance of a website. In addition, when a web page is requested from the Site, Company may record the time, date and URL of the request and information on the browser being used.
- b. **Personally Identifiable Information.** Portions in this Site are "registration-required" pages that may require you to submit personal information before we grant you access. In addition, if you submit an inquiry to us via the "Contact Us" link, you may be required to submit personal information. Such information may include your name, company name, address, e-mail address, phone numbers and other identifying information about you and your company,

including, but not limited to, Employer Identification Number (EIN), Motor Carrier number, insurance and license information and business references (individually or collectively, “Your Information”). In some instances, when submitting a W-9 form as part of your document packet, you may have the opportunity to provide a Social Security number as an alternative to the Tax Identification number by electronic facsimile or other means. We request that you do not use Social Security numbers on W-9 forms with any information packets provided to us and we will endeavor to prevent such forms from being accepted onto the Site. Note that such transmissions do not involve encryption or other secure means of transfer. You represent and warrant that you have all rights necessary to submit Your Information and to provide the consents and other rights granted with respect thereto under this Privacy Policy. You are responsible for the accuracy of Your Information. You agree that Portloads is only a facilitator of the Site and has no responsibility for the accuracy of Your Information.

II. How We Use Information We Collect.

- a. **Non-Personally Identifiable Information.** We may use non-personally identifiable information to measure the number of visits, average time spent on the Site and pages viewed as well as to diagnose problems with our servers and to administer the Site. We may then use this information to analyze and improve the features and functionality of this Site. Please note that we also may match non-personally identifiable information, such as your IP address, to your personally identifiable information in order to augment our ability to administer, and to optimize the Site for you. This data is not linked to any personal information or used to personally identify you, but may be aggregated to enable Portloads to perform business analytics, analyze trends, administer the Site, optimize the performance of the site, gather information regarding where visits to the Site originate, how often the Site is visited and what parts of the Site are visited most often. The server logs may include information such as your Web request, Internet Protocol address, browser type, browser language and the date and time of your visit.
- b. **Personally Identifiable Information.** You acknowledge and agree that Portloads may collect, use, display, transmit, monitor, store and disclose Your Information as set forth in this Privacy Policy and in connection with the Company’s business, products and services and operation of the Site and that Portloads does not assume any responsibility or liability for (i) any information you submit to the Site (ii) your or any third parties’ use or misuse of information transmitted or received using the Site. By providing Your Information, you agree and consent to Portloads sharing certain amounts of Your Information for any reason and to any person or entity, including, but not limited to, within our company, with third parties who subscribe to this Site, with third parties who work with us on marketing, product development, service enhancement and other similar matters. Portloads may sell, transfer or otherwise share some or all of its assets, including Your Information, in connection with a merger, acquisition, reorganization, restructuring or sale of assets or in the event of bankruptcy or insolvency. Without limiting the generality of the foregoing, we may use Your Information as follows:
 - i. **Site:** We may use Your Information to better tailor your Website experience to your interests, and to send you information about Portloads and its services as well as promotional material on behalf of some of our partners. We use other personally identifiable information that you provide to us to show you content in which you may be interested and to display the content according to your preferences. We will also share this information within the Portloads business family in order to enhance your experience on this and other Portloads Websites.
 - ii. **Administrative Matters:** Portloads reserves the right to contact you in the event of a change in the Site’s Terms of Service and/or this Privacy Policy, or to notify you of other administrative matters in connection with the Site (e.g., contacting you to facilitate, complete or confirm a transaction).

- iii. Transactions with E-Commerce Partners, Vendors and Advertisers: When you provide Your Information to one of our Site's e-commerce partners and vendors or advertisers, this transaction will occur in connection with the site of the e-commerce partner and vendor or advertiser, not on the Site, and, as such, the financial and other personally identifiable information you provide is collected pursuant to and controlled by the privacy policy of such e-commerce partner, vendor or advertiser. - iv. Please be aware that, in connection with the foregoing, Portloads may provide information about you gathered through other sites controlled, owned or operated by Portloads or our affiliates to the extent permitted under the applicable privacy policy governing collection and use of such information.
- vi. Banner Ads. Portloads sometimes uses individual data collected via the Site to "target" advertising - to decide which advertisements and sponsor messages to show to which members.
- vii. If any provision of this Privacy Policy, or the application thereof to any person or circumstances, is held invalid or for any reason, unenforceable including, but not limited to, the warranty disclaimers and liability limitations, then such provision shall be deemed superseded by a valid, enforceable provision that matches, as closely as possible, the original provision, and the other provisions of this privacy statement shall remain in full force and effect. The failure of either party to insist upon strict performance of any provision of this privacy statement shall not be construed as a waiver of any provision or right. Unless expressly provided otherwise, this Privacy Policy and the Terms of Service presented on this Site comprise the entire agreement between you and Portloads with respect to the use of this Site and shall not be modified except in writing, signed by an authorized representative of Portloads.
